# TERMS AND CONDITIONS

1. Booking: All group bookings require a confirmation on number as detailed in this document.
2. Bookings: A booking is confirmed with the payment of the deposit and agreements of the terms and conditions made under this booking.
3. Public Holidays: Functions booked on public holidays incur a surcharge for food of 20%.
4. Final numbers: To enable correct staffing, the final number of attendance must be confirmed at least 3 working days prior to the booking.
5. Payments: All accounts must be settled in full on the day on the booking. Deposits will be deducted from the final payment. We accept payments made in CASH, EFTPOS, VISA and Master Card. We do not accept American Express Card payments,
6. Damage and breakages: We accept that from time to time glass breakages occur. However, excessive glass damages or breakages to the venue items will be the responsibility of the organisers of the booking and any damage will be charged to the organisers.
7. Loss of goods: It is the responsibility of the organisers of the booking to ensure that all items brought to the brewery by the organising party or their invited guest are securely stored. The brewery does not accept any liability for items brought to the venue that are lost or damaged. This includes gifts such as birthday gifts or wedding gifts, cameras etc that are brought for displayed to the venue.
8. Cancellation: In the unfortunate event that the organisers need cancel the booking, the deposit is non-refundable.
9. Cleaning: If excessive cleaning is required due to an excessive mess created during the tour (inside or outside), cleaning charges of \$ 50/hour will be added. Confetti and Glitter/Rice are not permitted to be used inside and outside the venue.
10. Minors: Minors are welcome at the brewery when in the company of adults. Children must be supervised at all times and access limits must be adhered to at all times. Minors are not permitted to purchase, or consume alcohol while on the premise and the brewery staff may request suitable proof of age to establish a person's age.
11. Responsible serving if alcohol: The Prancing Pony Brewery serves alcohol responsibly and while drinks will be served by the customer, alcohol will not be served to intoxicated persons or to persons under the age of 18 years
12. Liability: The brewery conducts the function in compliance with the Liquor Licencing Laws and reserves the right to exclude or eject any person from the brewery that does not comply with these laws without liability.
